- 1. PLEDGE OF ALLEGIANCE.
- 2. CALL TO ORDER. President Bibeau called the meeting to order at 6:00PM.

- 4. **INFORMAL PUBLIC COMMENT TIME:** Chuck Fedie addressed the Board regarding the differences in the benefits between the Police Department and all the other full-time employees. Tim Wentz addressed the Board regarding his union member's feeling of inequality regarding the differences in the benefits between the two union contracts.
